Together We Learn and Grow'

Thursday 25th February 2021

Dear Parent / Carer

I hope that you are all well and you and your families remain in good health. I am delighted to finally be writing to you all with details for the full return of **ALL** pupils on **Monday 8th March 2021**. Further to the government's latest guidance we are now in a position to provide some additional detail in how we will welcome you all back – this time for good hopefully!

Arrangements have once again been very carefully planned, prioritising the safety of the children and staff. Whilst we must be clear that we cannot eliminate all risks, we have carefully followed all the latest government guidance and advice from Public Health England in the planning of increasing numbers in school and much of what was implemented during the autumn term will be re-introduced. We have worked closely with the Local Authority, within our Trust and staff to review comprehensive risk assessments and protocols.

As you can imagine, once again there is a lot of information to share with parents and carers and I would encourage you to read this through carefully to the end as we try to give as much detail and answer any questions you may have. There are some slight changes from the previous guidance and it is vital that we refresh ourselves of the important measures and arrangements in place for the return to school. We will also be putting this letter onto the website under the COVID section for ease to access.

Bubbles:

Bubbles will resume as in the autumn term. Minimising contacts and mixing between people reduces transmission of COVID-19. Consistent groups reduce the risk of transmission by limiting the number of pupils and staff in contact with each other to only those within the group. Maintaining distinct groups or 'bubbles' that do not mix makes it quicker and easier in the event of a positive case to identify those who may need to self-isolate and keep that number as small as possible.

The children will be kept in groups (bubbles) as classes and then within phases to support with lunchtime arrangements. This means children will be in one of the following:

Early Years Bubble	Children from nursery and reception
Key Stage 1 Bubble (KS1)	Children from years one and two
Lower Key Stage 2 Bubble (LKS2)	Children from years three and four
Upper Key Stage 2 Bubble (UKS2)	Children from years five and six

Interaction will still be limited, and we will encourage social distancing with the older children. It is recognised that younger children will not be able to maintain social distancing, and it is acceptable for them not to distance within their group. Children will be kept in their class groups for the majority of time, with the exception of start and end of the day, break times and lunchtimes where they will be in their bubbles but separated to maintain class bubbles. Siblings will also be in different groups.

School will still be a little different however, as has been proven when we returned in the autumn term, we will make it as welcoming, warm and fun as we always do. GSP is a safe, happy place to be in which lots of learning will continue, regardless of the measures we currently have to put in place.

We have carefully followed government guidance and put in place a number of measures to support in reducing the risk of infection. The following sections have been grouped to support any wider questions you may have.

Entry and exit of school

- Start and end times to the school day are staggered as best as is possible. This is to reduce congestion and adhere to social distancing. We have shortened the staggered times as, through the autumn term, this system proved efficient and timing in between moved more quickly as everyone got used to the system.
- Strictly only one adult per child (sibling group) will be allowed onto the school premises at drop off and pick up to reduce numbers
- In the morning, parents will walk down the red path (maintaining social distancing) and will drop their child off at the green gate outside the school hall. Staff members will be available to safely get the children into school grounds. Throughout our most recent 'lockdown' children in nursery upwards have been coming in independently from the point of the school gate, being met be a member of the EYFS team familiar to them. This will continue.
- Parents will exit school, following the clearly labelled arrows and directions, using the one-way system, which will allow them to leave via the dis-used gate which runs at the back of the car park, this gate will be open during this time. It is important that you keep your child with you as you move around the back of the school. Sadly, a small minority of parents allowed their children to run ahead during the autumn term, mixing with other bubbles and veering off the path and onto the steep embankment. This has resulted in us having to staff the back of the school when we would rather utilise their time in other ways. We ask that you keep your child with you as you leave the school premises.
- Children will enter school by the means mentioned above for each year group, support staff will be available on the playground and around corridors to encourage social distancing
- The finish times for the end of the day are staggered, parents will be encouraged to only enter school premises when it is their pickup time for their child.
- Parents will wait in the main playground for their child to exit. Please remember to keep your distance from others to support with our social distancing enforcements. Once your child is out, they will join the red track (daily mile track) and will follow it at 2-metre distance using the one-way system to the rear of the school building as previously.
- We are discouraging parents in accessing the school office, unless in an emergency until further guidance allows and any messages or notes will be passed at the gate in the morning or can be emailed or phone into school. If you do need to visit the office, please note that only one person may enter at any one time.
- Parents should not congregate outside the school gates at any time, this is important to support with social distancing and when members of the public are walking past.
- **Siblings:** As timings have now been minimised, we ask for your patience when collecting children as they must maximise their learning time in school so will not be allowed any early concessions due to siblings. However, in the morning drop off, as previously, parents with siblings will be asked to drop off all children at the earliest time they have been given. Siblings will enter the hall until their allocated time and wait in a designated area, supported by teaching assistants.
- It is important that you stick closely to your allocated times.
- Face masks must be worn at all times unless there is a medical exemption.

Start and end times for all pupils

We ask that parents strictly stick to these times to support us in the logistics of all children arriving at staggered intervals.

Hygiene

- Hand washing on entry into school, when entering outdoor areas / playground and on entry back into school, before and after eating. Handwashing at regular intervals throughout the day
- Regular wiping down of surfaces / equipment throughout the day
- Sanitiser units remain in every classroom and at key entrance points throughout the building to support with hygiene
- Increased cleaning throughout the day has been timetabled to support with maintaining hygiene and cleanliness
- The school owns a 'fogger' which will be used regularly to support with deeper cleaning of classrooms

Uniform

- Children should return to school in full school uniform and there will be an expectation that all children are smart and ready to learn. This includes appropriate footwear, hair accessories and no jewellery or nail varnish. The full school uniform policy is available on the school website
- Children should come to school wearing their PE kit on the day they have their lesson. This information is on their class page on the website if you are unsure

Lunchtime Arrangements and snack time

- Children will eat their lunches in their class bubble in the school hall at staggered intervals from the other bubbles
- A full hot meal service remains available alongside those children wishing to bring in packed lunches

Classroom Arrangements

- Classrooms continue to promote social distancing, including desks facing forward as in the guidelines and personal resources where appropriate, whilst retaining a warm and welcoming classroom atmosphere
- Maintaining a distance between people whilst inside and reducing the amount of time they are in face to face contact lowers the risk of transmission. Ideally adults should maintain a 2-metre distance from each other, and from children. We know that this is not always possible, particularly when working with younger children. Similarly, it will not be possible when working with pupils who have complex needs or who need close contact care. We have made small adaptations to the classroom to support distancing where possible
- Movement around the school will be kept to a minimal, including avoiding large gatherings such as assemblies and collective worship

Enrichment

Enrichment is clearly a strength of our school and we want to bring this back at the earliest opportunity. However, it is important that we establish our daily routines before we embark further on after school and lunchtime activities. In addition to this, sadly, the required staggering of lunch time and the separation of phases means that enrichment won't be able to run as it has done previously. We will continue to offer a rich and varied enrichment offer when we are able to do so fully and this will be reviewed after the Easter half term or as new guidance is released

Resources

- Children must not share resources such as stationery, so we will allocate stationery where appropriate. In KS2 children are provided with a pencil case
- Children are allowed to bring in bags from home
- Children can take home reading books. Books returned that will be shared outside the wider bubble will be cleaned and 'quarantined' for 48 hours
- Areas will be resourced as normal to ensure effective educational provision is in place
- Each bubble across school will be provided with an outdoor play box. This will be kept within the bubble and returned to the classroom / key identified area each day. They will also be on a rota system to access the wider outdoor equipment

Managing online learning and teaching in school

- Google Classrooms will remain active and continue to be used for homework and any bubble closures
- The guidance issued by the DfE is clear in its expectations that pupils who have to self-isolate should be able to switch to remote learning immediately.

Attendance

Now that circumstances have changed it is vital that children return to school so that we can minimise as far as possible the longer-term impact of the pandemic on children's education, well-being and wider development.

Any further absences away from the classroom will risk pupils falling further behind. There is a strong link between good school attendance and achievement.

School attendance will therefore be mandatory once again from March 8th with the exception of children who have been confirmed as clinically extremely vulnerable and have received a shielding letter. This means that the usual rules will apply, including:

- parents' duty to secure that their child attends regularly at school where the child is a registered pupil at school, and they are compulsory school age
- schools' responsibilities to record attendance and follow up absence
- the availability to issue sanctions, resulting in prosecution for poor school attendance

We recognise that some parents and pupils may feel anxious and worried about their return and in addition to the guidance shared here, we will work closely with families to support you with their return to school.

We recognise that parents and children may be returning with some trepidation, all from different starting points. As in the previous lockdown, we have remained open throughout the lockdown period and have been meticulous in our approach, whilst still ensuring children attending felt settled and safe. I hope that you are reassured, like last time, with the details and careful planning with regards to the reopening including how and when we communicate, to ensure that we minimise any confusion and risks as children return fully. We hope that parents feel reassured by the finer details included within this letter and in the way we have safely managed the children of critical workers throughout this latest lockdown. It is imperative that whilst restrictions remain in place that we all do our utmost to reduce any risks of infection. Families must continue to follow the government's rules in place until the point at which they are lifted, if these are not being followed and families are unlawfully mixing, it could potentially mean that you are putting the wider school community at increased risk so we urge you to continue to be cautious.

We are looking forward to welcoming all our children back into school and staff will continue to work hard to follow all guidance, all with the best interests of the children at the forefront. Our intention is to give you as much information now as possible, hence the lengthy letter, all at once rather than in lots of correspondence. This is a 'go to' information letter that covers all aspects of the return. We are confident that the details and planning we have adopted are considered good practice and will allow for the return of all pupils back at GSP to engage in a full, exciting broad and balanced curriculum.

Thank you for all your ongoing engagement with the Google Classrooms, I know many of you have found this challenging but everyone should be very proud of how the children have worked. Your kindness and support have been greatly valued throughout this challenging time.
